- 1. - 4. If, number of application received for the post of Nursing Attendant is large, then the Institution Authority reserves the right to lay down any criteria for the purpose of short listing of the candidates.
- In case the institution decides to hold written examination for short listing eligible candidates, final merit list for the post shall be prepared on the basis of total marks obtained by the candidate in the examination which will determine their position. If two or more candidates secure equal marks, the candidate older in age shall be placed above. No personal cheques are accepted. The Application Fee will be non-refundable. Application without the prescribed fee would not be considered and summarily rejected. All the applicants are advised to keep a copy of payment Slip with them, for their record.

7. Candidates applying under any reserved category will be considered subject to submission of caste/category certificate on a prescribed format, issued by the Govt. of India.

Essential documents:-

(i) All the candidates must attach one set of **self-attested** photocopy of the certificates for age, educational qualifications, experience certificate not more than three (3) months old, valid Caste/EWS category certificates, valid disability certificate whichever applicable and other required documents.

(ii) Ex-servicemen candidates concerned would be required to produce a certificate that they have been released from the Defence Forces along with an undertaking as in ANEXURE –III. The certificate for Ex-servicemen and Commissioned Officers including ECOs/SSCOs should be signed by the appropriate authority specified below and should also specify the period of service in the Defence Foreces:-

9. The maximum age mentioned above is for general category candidates. Upper age limit is relax able for OBC as per Govt. of India Policy/instructions issued from time to time. The age relax able for reserved category candidates is admissible only in the case of candidates who apply against the post meant for reserved category. The reserved candidates who apply against post meant for UR category are not entitled to get age relaxation. The upper age limit shall be determined as on the last date of application as specified. Date of birth filled by the candidate in the application form and the same recorded in the Matriculation /Secondary Examination Certificate will be accepted by the institution for determining the age and no subsequent request for change will be considered or granted. Age relaxation permissible to various applicants is as under as per Govt. of India Policy.

- OBC Candidates should not belong to Creamy Layer. The Non-Creamy Layer Certificate would be applicable to OBC candidates who are covered under Income/Wealth Test Criterion. The income limit is decided on the basis of income earned during three previous financial years preceding the year of appointment. Their Sub-caste should be tallied with the Central List of OBC, failing which their candidature will not be considered under any of the applied reserved category and will be treated as UR.
- 11. Candidates applying under OBC will be considered subject to submission of Caste certificate on a prescribed format issued by the competent authority. Candidates applying under OBC Category must bring the latest caste certificate in the format provided by the DoP&T vide O.M No.36036/2/2013-Estt(res) dated 30.5.2014 which has been issued not earlier than one year from the last date of receipt of application. Certificate must be valid for employment in Central Government Institutions.
- 12. For person with Disability, Disability Certificate issued by the duly constituted and authorized Medical Board in the Performa Prescribed by the Department of Personal & Training Vide .M No.36035/02/2017-Esst (res.) dated 15/01/2018. The details regarding PWD may be seen at Annexure-IV.
- 13. Those who are regularly employed with State/Central Govt./PSU, must submit a "No OBJECTION CERTIFICATE" from the employer at the time of verification of documents.
- 14. The incumbent to the post of Nursing Attendant shall be governed by the New Pension Scheme (NPS) as notified by the Central Government.
- 15. No correspondence or personal inquires shall be entertained.



- 4. All PWD candidates with disabilities mentioned in section 32(1) of Right of Persons with Disability Act, 2016, are eligible to apply under this category provided they have benchmark disability of equal to or more than 40%. A person who wants to avail the benefit of reservation will have to submit a certificate of disability issued by a Competent Authority. Such certificate in the event of selection of such person for any post will be subject to such verification/ re-verification as may be decided by the Competent Authority.
- 5. Applicant should make sure that he/she is to be able to meet physical requirement of OA, OL, OAL, and HH for the post of Nursing Attendant.
- 6. After any candidate qualifies the written examination, such candidates will be subjected to medical examination by a Medical Board of LHMC to ascertain their Suitability for the job.
