To fill up the regular sanctioned 210 posts of Staff Nurses in new established Shri Atal Bihari Vajpayee Government Medical College, Chhainsa, Faridabad -Submission of selection list from the waiting as well as merit list.

I have been directed to inform you that the State Government has decided to start the newly established Shri Atal Bihari Vajpayee Government Medical College, Chhainsa, Faridabad as a COVID Hospital on URGENT basis to manage the upsurge of COVID-19 pandemic in the State. Need not to mention the URGENCY with which the Indian Army has taken over the premises to run the institution and to aid and assist in managing the situation in Faridabad as it is facing the huge influx of patients from Delhi. Without trained staff the hospital can't function. Therefore, it has been decided to appoint the regular 210 Staff Nurses against the sanctioned posts for GMC Faridabad over and above the advertised posts. It has been the settled legal opinion based on a catena of judgements of H' Supreme Court of India in 'Surinder Singh & others vs State of Punjab & others, 1997(4) SCT 133' etc. to offer the appointment over and above the advertised posts only in extreme exceptional circumstances. Considering the present circumstances, it has been decided that these 210 posts of Staff Nurses posts shall be filled up from the waiting list and the merit list of all categories of Staff Nurses prepared after the conduct of the examination by UHS Rohtak in Dec. 2020 for PGIMS, Rohtak and other 3 Government Medical Colleges in the State. So you are requested to take action on the following points

- Publish a public notice in the leading newspapers as well as on the website of the 1. UHS, Rohtak, inviting options/consent in the shape of an affidavit from the eligible candidates i.e. from waiting list and merit list for consideration of appointment of Staff Nurses in Shri Atal Bihari Vajpayee Government Medical College, Chhainsa,
- On receipt of the options from the eligible candidates, the Selection Committee shall 2. make a selection list from the waiting list and the merit list of the candidates strictly as per the merit and as per the Reservation Policy issued by the General Administration Department (GAD). The list of Roster points prepared by the Director of Shri Atal Bihari Vajpayee Government Medical College, Chhainsa, Faridabad is enclosed herewith.

You are requested to recommend the names of the selected candidates for the posts of Staff Nurses to be appointed/recruited for Shri Atal Bihari Vajpayee Government Medical College, Chhainsa, Faridabad by 17/05/2021 positively.

This may be treated as MOST URGENT.
