- 3. The experience requirement specified shall be experience acquired after obtaining the minimum educational qualifications required for the post.
- 4. Persons working in Govt. / PSUs / autonomous bodies should apply through proper channel or produce 'No Objection Certificate' at the time of written test/skill test/Interview.
