### Fee Payable

Rs. 1000/- for General/OBC Candidates and Rs. 500/- for SC/ST Candidates. PwD candidate are exempted from fee. The fee can be deposited through Demand Draft in favour of "Director-Principal, MAIDS" payable at New Delhi. No Fees for PwD candidates.

Fee once paid will not be refunded in any case.

#### **Mode of Selection**

The selection will be made through screening (Written & Skill) test and followed by interview of shortlisted candidates.

"It will be the responsibility of the applicant to ensure that they fulfils the educational/ technical qualification, eligibility criteria, Caste Certificate, Age Proof or any other relevant documents pertain to this during the scrutiny of documents or at the time of screening test/interview if found any deficiency or any concealment of fact their candidature/appointment will be cancelled.

#### **Documents to be attached s**

Self attested scanned copy of all certificates in support of age, caste, qualification, experience, two passport size photographs, etc are to be attached with application form.

"OBC Certificate should be issued from Govt. of NCT of Delhi as "OBC (Delhi)". OBC Certificate issued from any state other than Delhi or certificate issued from Govt. of NCT of Delhi but on behalf of any other state will not be considered. General candidates are not eligible to apply against reserved category post".

Note: Application received after the due date will not be consider in any circumstances and the fee paid will also not be returned.

#### **Other Terms and Conditions**

- 1. The present vacancy arose as the regular incumbent has been sent on deputation for a short period. In case the regular incumbent sent on deputation does not report within 06 months, based on the service record of the contractual employee so appointed against the post. The period of contractual engagement can be extended for a short period by the institute.
- 2. The said contractual engagement is purely on contract basis for a period of one year only and it shall be deemed to have automatically come to end on expiry of the said engagement period or till a regular incumbent joins the post, whichever is earlier.
- 3. The engagement is purely on contractual basis and it can be terminated by the institute i.e. Maulana Azad Institute of Dental Sciences during the currency of the agreement without assigning any reason or giving any notice.
- 4. The contractee shall have to give one month notice or deposit an amount equal to one month remuneration if he/she wishes to terminate the contract or as per decision of the competent authority.

- 5. Any unauthorized absence from more than five days will lead to termination of the contract.
- 6. The contractee will sincerely perform the duties assigned to him/her by the Institute authorities to the satisfaction of the Institute authorities. He/She shall remain polite and courteous to the staff members, patients and their attendants and shall abide by the rules and regulations of the Institute.
- 7. It will not be the responsibility of the institute to provide accommodation to the Contractee. The Contractee shall not be entitled for any government accommodation.
- 8. The contractual appointee will not be entitled to financial benefits/concessions or medical facility as admissible to Govt. Employees.
- 9. The contractual appointee will not be granted any claim or right for regular appointment to any post.
- 10. The appointee shall be on the whole time appointment of the institution and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.
- 11. Scope of work assigned & other conditions as mentioned above may be clearly detailed in the contract.
- 12. Leave admissibility to the employee during the contract period will be as under:
  - a. Earned Leave will be granted @ Two and half days per month of completed service.
  - b. The leave will be granted in full days only.
  - c. Maternity leave as per Maternity Benefit Act, 1961.
  - d. Leave encashment on termination of service or during the currency/expiry of contract period is not allowed.
  - e. No other leave is admissible.
